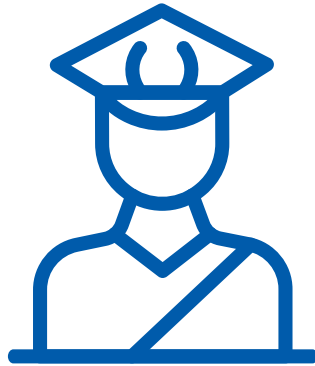

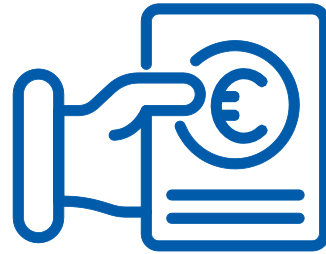

## FISCAL CLEARANCE

**As an official fiscal representative in Germany we are a privileged interlocutor for German tax and customs agencies.**

- Completing customs formalities across Germany through Germany's ATLAS e-customs system used to contact all customs offices throughout the country.
- Clearance procedures with relief from the immediate payment of import VAT. The importer settles it later in their tax return with the local tax office as a levy for the intra-EU acquisitions of goods (increasing financial liquidity).
- Immediate market authorization after customs clearance.
- Fiscal clearance conditions:
  - The importer is not based in Germany
  - The importer holds a valid VAT-EU tax identification number
